### TAXICAB BROKER BUSINESS LICENCE APPLICATION MUNICIPAL CODE CHAPTER 327

For the past 25 years, Brantford Police Services has been responsible for administering the system of licensing the taxi industry in the City of Brantford. Effective January 1, 2018, this function will be transferred to the City Clerk's Department and incorporated into the City's Business Licensing Program

# On November 28, 2017, City Council passed the Taxicab Licensing bylaw. As a result of this bylaw, Taxicab Brokers, Drivers and, Operators will now be licensed through the City of Brantford.

## **Taxicab Broker**

A "Taxicab Broker" shall mean any person who accepts calls in any manner for taxicabs that are used for hire and that are not owned by that person or that person's immediate family or employer.
