### Article 1

#### CHIEF PROPERTY STANDARDS OFFICER APPOINTMENT

##### 132.1.1 Russell Thomson

## **Article 3**

### **PROPERTY STANDARDS OFFICER - WEST NILE VIRUS**

#### **132.3.1 Administration**

Despite Sections 132.1.1, 132.1.2 and 132.2.1, the administration and enforcement of Article 28 of Chapter 465 of the City of Brantford Municipal Code shall be performed by employees of the Brant County Health Unit.

#### **132.3.2 Appointment**

For the purposes of the administration and enforcement of Article 28 of Chapter 465 of the City of Brantford Municipal Code:

- (a) the Programme Manager, Environmental Health and Inspection Services is the Chief Property Standards Officer employed by the Brant County Health Unit; and
- (b) all public health Inspectors employed by the Brant County Health Unit are hereby appointed as Property Standards Officers. By-law 102-2003, 26 May, 2003.

## **Article 4**

### **REPEAL - ENACTMENT**

#### **132.4.1 By-law - previous**

By-law 5-86 of The Corporation of the City of Brantford is hereby repealed.
