**Article 1
GENERAL PROVISIONS**

354.1.1 Keeping - storing

No person shall keep or store gasoline, diesel fuel oil, other oils and other fuels within the City of Brantford without having first obtained a licence under this Chapter.

354.1.2 Fee - annual

The annual fee for such licence, when granted, shall be \$35 per tank.

354.1.3 Application - Chapter 326

The provisions of Chapter 326 of the City of Brantford Municipal Code apply to this Chapter.

**Article 2
INSTALLATION - MAINTENANCE**

354.2.1 Applications - removals - plans - location access

For initial applications or tank removals, the applicant shall submit to the Issuer of Licences, plans showing the location of the tanks and the means of access from municipal streets or public highways.

354.2.2 Plans - accurate measurements

The plans required under Section 354.2.1 shall contain accurate measurements of distance from the edge of the travelled portion of the municipal street or public highway.

354.2.3 Letter of approval - required - installer

It is the responsibility of the installer to obtain a letter of approval from the municipality prior to the commencement of any tank installation or removal.

354.2.4 Letter of approval - fee required

A fee of \$25 is required for a letter of approval from the municipality for any tank installation or removal.

354.2.5 Exception - Chapter - not applicable

This Chapter shall not apply to oil burning appliances and equipment.

354.2.6 Compliance - all regulations - approval required

When a licence is granted under the provisions of this Chapter installation and maintenance of the tanks shall be according to the Liquid Fuels Handling Code issued under the *Technical Standards and Safety Act 2000*, and all regulations made under same, and in accordance with Chapter 507, City of Brantford Municipal Code or its successor, and with approval of the Chief Fire Official or his or her delegate, the Brantford Fire Department, Chief Building Official, and Engineer.

354.2.7 Approvals - other agencies - applicant - to obtain

The applicant shall obtain all required approvals from such other regulatory agencies as may be required for the circumstances.

354.2.8 Consent - in writing - of owner - tenant - to obtain

In the case where the applicant is a tenant of the subject property, no licence shall be issued until the tenant has obtained the consent and approval, in writing, of the owner. This consent will be filed with the application. By-law 169-2001, 12 November, 2001.
