## **Article 1**

### **PUBLIC UTILITIES COMMISSION**

#### **52.1.1 Water - transit - powers - transfer to City**

All existing powers of the Public Utilities Commission of the City of Brantford in relation to the provision of water and the provision of public transit services are hereby assumed by The Corporation of the City of Brantford pursuant to the *Municipal Act*, R.S.O. 1990, c. M.45, s. 210.4 and O.Reg. 214/96, s. 5(1).

#### **52.1.2 Name change**

The name of the Public Utilities Commission of the City of Brantford is hereby changed to the Hydro-Electric Commission of the City of Brantford, pursuant to the *Municipal Act*, R.S.O. 1990, c. M.45, s. 210.4 and O.Reg. 214/96, s. 5(1).

#### **52.1.3 By-law - resolutions - previous**

Except for any by-laws or resolutions of the Public Utilities Commission of the City of Brantford which fix fees, service charges, fares, rates or other charges of a similar nature, any by-laws or resolutions of the Public Utilities Commission of the City of Brantford which have been continued as by-laws or resolutions of The Corporation of the City of Brantford pursuant to O.Reg. 214/96, s. 6(2) are, to the extent that they become by-laws or resolutions of The Corporation of the City of Brantford, hereby repealed. By-law 29-97, 24 February, 1997.

## **Article 2**

### **HYDRO-ELECTRIC COMMISSION**

#### **52.2.1 Composition - members - six**

The Hydro-Electric Commission of the City of Brantford shall on and after the 1st day of January, 1945, consist of six members, of whom the head of the Council shall *ex officio* be one and the remaining five shall be elected at the same time and place and in the same manner as the members of the Council, one for each ward in the City and the elected members shall hold office for a period of one year. By-law 2915, 11 September, 1994; By-law 29-97, 24 February, 1997.

## **Article 3**

### **REPEAL - ENACTMENT**

#### **52.3.1 By-law - previous**

Section 2 of By-law 2452 of the said City of Brantford is hereby repealed as and from the 1st day of January, 1945.

**52.3.2 Effective date**

This Chapter shall take effect from the passing thereof. By-law 2915, 11 September, 1944.

**52.3.3 Effective date - By-law 29-97**
