**Article 1  
INTERPRETATION**

**619.1.1 Bicycle path - defined**

“bicycle path” means any path, route or way through any land owned or maintained by The Corporation of the City of Brantford, not having been dedicated as a highway that has been designated for the use of bicycles other than motor assisted bicycles or power-assisted bicycle, or for the exclusive use of both pedestrians and bicycles other than motor-assisted bicycles or power-assisted bicycle. By-law 36-2014, 24 March, 2014.

**619.1.2 Closed roadway or drive - defined**

“closed roadway or drive” means that part of any drive, roadway or property designated by signs by the City for parking vehicles.

**619.1.3 Dike - defined**

“dike” means an embankment, long ridge, dam or other natural or man made defence against flooding located on any land owned or maintained by The Corporation of the City of Brantford.

**619.1.4 Footpath - defined**

“footpath” means any path, route, or way set aside solely for the use of pedestrians and includes any path, route or way on any land that is owned or maintained by The Corporation of the City of Brantford and has been designated for the use of pedestrians.

**619.1.5 Moto-assisted bicycle - defined**

“motor-assisted bicycle” means a motor-assisted bicycle as defined by the *Highway Traffic Act*, R.S.O. 1990, c. H.8, as amended from time to time.

**619.1.6 Motorized snow vehicle - defined**

“motorized snow vehicle” means a motorized snow vehicle as defined in section 1 of the *Motorized Snow Vehicles Act*, R.S.O. 1990, c. M.44, as amended from time to time.

**619.1.7 Parking space - defined**

“parking space” means that part of any drive, roadway or property designated by signs by the City for parking vehicles.

**619.1.8 Person - defined**

“person” includes any body corporate or politic, and the heirs, executors, administrators or other legal representatives of a person to whom the context can apply according to law. By-law 87-83, 20 June, 1983.

**619.1.9 Power-assisted bicycle - defined**

“power-assisted bicycle” means a power-assisted bicycle as defined by the *Highway Traffic Act*, R.S.O. 1990, c. H.8, as amended from time to time. By-law 36-2014, 24 March, 2014.

**619.1.10 Property - defined**

“property” means any land and/or premises owned or maintained by The Corporation of the City of Brantford excluding public highways.

**619.1.11 Roadway or drive - defined**

“roadway or drive” means that portion of land owned or maintained by The Corporation of the City of Brantford for vehicular use but does not include a public highway or service lane.

**619.1.12 Vehicle - defined**

“vehicle” means a vehicle as defined by the *Highway Traffic Act*, R.S.O. 1990, c. H.8 as amended from time to time.

**Article 2**  
**GENERAL PROHIBITIONS**

**619.2.1 Driving - off road - exception - emergency**

No person shall on any property owned or maintained by the Corporation of the City of Brantford, drive any vehicle, other than authorized emergency vehicles, on such properties except on roadways or drives.

**619.2.2 Obstruction - traffic - pedestrians**

No person shall on any property owned or maintained by The Corporation of the City of Brantford, stand any vehicle on a roadway or drive in such a manner as to obstruct traffic or pedestrian travel.

**619.2.3 Parking - improper location**

No person shall on any property owned or maintained by The Corporation of the City of Brantford, park any vehicle on a roadway or drive except at a designated parking space.

**619.2.4 Driving - service lane - without permission**

No person shall on any property owned or maintained by The Corporation of the City of Brantford, drive any vehicle on any roadway or drive designated as a service lane without the permission of the City.

**619.2.5 Driving - closed roadway - drive**

No person shall on any property owned or maintained by The Corporation of the City of Brantford, drive any vehicle upon a closed roadway or drive.

**619.2.6 Operation - excess of 20 km/h - dangerous**

No person shall on any property owned or maintained by The Corporation of the City of Brantford, operate any vehicle at a speed in excess of 20 km an hour, or so as to interfere with or endanger any person.

**619.2.7 Improper parking - vehicle towed - owner's expense**

No person shall on any property owned or maintained by The Corporation of the City of Brantford, park or stand any vehicle on any such property other than in areas designated as a parking or standing area. All vehicles so parked or standing must be parked or standing in conformity with the line or markings designated therefore. Vehicles parked in contravention of this Section shall be towed away by the City or its agent at the owner's expense. By-law 87-83, 20 June, 1983.

**619.2.8 Operation - vehicles - improper location**

No person shall, on any property owned or maintained by The Corporation of the City of Brantford, including, but not limited to any bicycle path, drive or operate any vehicle, motorized snow vehicle, motor-assisted bicycle, power-assisted bicycle, or bicycle on any such property except any such property designated for the use of such vehicle, motorized snow vehicle, motor-assisted bicycle, power-assisted bicycle or bicycle, as the case may be. By-law 36-2014, 24 March, 2014.

**619.2.9 City vehicles - exception**

This Chapter shall not apply to vehicles owned or operated by The Corporation of the City of Brantford its servants, agents or employees, or by any local board thereof where it is necessary for such vehicles to enter upon any property. By-law 87-83, 20 June, 1983.

**619.2.10 Operation - power-assisted - motor-assisted - restriction**

Without limiting the generality of any other provision of this Chapter, no person shall operate any motor-assisted bicycle or power-assisted bicycle on any bicycle path owned or maintained by The Corporation of the City of Brantford. By-law 36-2014, 24 March, 2014.

**Article 3  
ENFORCEMENT**

**619.3.1 Fine - for contravention**

Every person who contravenes any of the provisions of this Chapter is guilty of an offence and shall, upon conviction thereof, forfeit and pay a penalty of not more than \$5,000, exclusive of costs and every such fine is recoverable under the *Provincial Offences Act*.
