BY-LAW NUMBER 99-2024 OF THE CORPORATION OF THE CITY OF BRANTFORD

Being a By-law to amend By-law 021-2024, being a By-law to Fix Fees and Charges to be collected by The Corporation of the City of Brantford for 2024-2027.

WHEREAS the Corporation of the City of Brantford is responsible for the administration and enforcement of the Building Code Act, 1992, S.O. 1992, c. 23 (the "Building Code Act") to issue building permits thereunder, and to enact by-laws to require the payment of fees for the issuance of building permits and for related activities;

AND WHEREAS Chapter 429 of the Municipal Code of the City of Brantford ("Chapter 429") has been enacted as a by-law requiring the payment of such fees;

AND WHEREAS Chapter 429 provides that the amount of such fees are provided in the City of Brantford Fees and Charges By-law

AND WHEREAS By-law 021-2024 is the current City of Brantford Fes and Charges By-law, enacted under the authority of Part XII of the Municipal Act, 2001 to fix fees and charges imposed on persons:

- (a) for services and activities provided or done by or on behalf of it;
- (b) for costs payable by it for services and activities provided or done by or on behalf of any other municipality or any local board; and
- (c) for the use of its property including property under its control;

AND WHEREAS City Council has determined that the fees and charges pertaining to building permits and related activities set forth in By-law 021-2024 should be amended as set forth in this By-law;

AND WHEREAS a public meeting conforming with the requirements of section 7 of the Building Code Act was held on June 11th, 2024, in respect of the fees and charges amended by this By-law;

THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE CITY OF BRANTFORD HEREBY ENACTS AS FOLLOWS:

1. By-law 021-2024, as amended, is hereby further amended by repealing the Fees and Charges identified by reference numbers 1042 to 1093, inclusive, in Schedule "1" thereto and substituting for them the replacement Fees and Charges identified in Schedule "1" attached to this By-law.

2. This By-law comes into effect immediately.
