

**BY-LAW NUMBER 81-2021**  
**OF**  
**THE CORPORATION OF THE CITY OF BRANTFORD**

*Being a By-law to amend By-law 52-2021, being a By-law to Fix Fees and Charges to be collected by The Corporation of the City of Brantford for 2021.*

WHEREAS By-law 52-2021 as amended, is a By-law passed under the authority of Part XII of the Municipal Act, 2001 to fix fees and charges;

AND WHEREAS City Council has determined that the fees and charges set forth in By-law 52-2021 should be amended as set forth in this By-law;

**THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE CITY OF BRANTFORD HEREBY ENACTS AS FOLLOWS:**


1. In this By-law, references to By-law 52-2021 shall mean By-law 52-2021 as amended from time to time.
2. By-law 52-2021 is hereby amended by amending Schedule (1) to the by-law in the following fashion:
  - a. Reference Number 356 is amended by deleting "Driveway Permit- new residential driveway", "per permit" and "\$178.50";
  - b. Reference Number 357 is amended by deleting "Driveway Permit- Extension or additional residential driveway", "per permit" and "\$61.20";
  - c. Reference Number 358 is amended by deleting "Driveway Permit- commercial driveway", per permit" and "\$178.50";
  - d. Reference Number 359 is amended by deleting "Street Cut Excavation Permit", "per permit" and "\$178.50";
  - e. Reference Number 382 is amended by deleting "Road Occupancy Fee (Partial Road)", "<= 30 days" and "\$76.72" and inserting "Right of Way Permit", "per permit" and "\$100.00";
  - f. Reference Number 383 is amended by deleting "Road Occupancy Fee (Partial Road)", "> 30 days" and "\$153.45" and inserting "Right of Way Permit- Expedited Processing", "per permit" and "\$75.00";
  - g. Reference Number 384 is amended by deleting "Road Occupancy Fee (Full Road with Detour)", "<= 30 days" and "\$248.23" and inserting "Right of Way Permit- Amendment, Renewal or Extension", "per permit" and "\$50.00";
  - h. Reference Number 385 is amended by deleting "Road Occupancy Fee (Full Road with Detour)", "< 30 days" and "\$496.45" and inserting "Right of Way Permit - Inspection", "per inspection" and "\$100.00";

- i. Reference Number 386 is amended by deleting "Road Occupancy- Permit Amendment or Extension", "per permit" and "\$41.52";
- j. Reference Number 387 is amended by deleting "Road Occupancy - Expedited Permit Processing", "per permit" and "\$56.42 - \$365.04";
- k. Reference Number 388 is amended by deleting "Non-compliance of Approved Road Occupancy Permit", "per day" and "\$50.00".

3. This By-law comes into effect immediately.
