# BYLAW NUMBER 182-2002 OF THE CORPORATION OF THE CITY OF BRANTFORD

To amend Bylaw Number 144-88, being a bylaw to regulate Parking within the City of Brantford.

WHEREAS the Engineering, Public Works, Parks and Recreation Committee of the Council of The Corporation of the City of Brantford has recommended to Council for the improvement and better regulation of parking within the City of Brantford;

AND WHEREAS the Council desires to implement the recommendations of the Committee as aforesaid;

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CITY OF BRANTFORD ENACTS AS FOLLOWS:

### 1. RE-PARK/NO RE-PARK

a) THAT Section '1(bb)' of Parking Bylaw 144-88 which pertains to "Definitions" be repealed as follows:

Re-Park/No Re-Park – prohibits a person from over-extending a 2 hour parking restriction through the relocation of a vehicle to another on-street location. A person is, therefore, prohibited from re-parking a vehicle at another on-street location in the downtown as identified in Section '31' for a period of 5 hours from the start of the initial period of having parked the vehicle on-street.

b) <u>THAT</u> Section '1(bb)' of Parking Bylaw 144-88 which pertains to "Definitions" be amended to provide for the following:

Re-Park/No Re-Park — prohibits a person from over-extending a 2 hour and/or 3 hour parking restriction through the relocation of a vehicle to another on-street location. A person is, therefore, prohibited from re-parking a vehicle at another on-street location in the downtown as identified in Section '31' for a period of 5 hours from the start of the initial period of having parked the vehicle on-street.

c) <u>THAT</u> Schedule '28' of Parking Bylaw 144-88 which pertains to the "List of Voluntary Payments" be amended to include the following:

### 2. <u>TIME LIMIT EXEMPTION AREAS</u>

<u>THAT</u> Schedule '30' of Parking Bylaw 144-88 which pertains to "Time Exemption Areas" be amended as follows:

a) THAT Schedule '11' of Parking Bylaw 144-88 which pertains to "Alternate Side of Street Parking, Monday through Saturday, All Year" be repealed as follows:

Grey Street	From a point 76m east of the centre line of Rawdon Street to Stanley Street	South	<u>North</u>

c) THAT Schedule '10' of Parking Bylaw 144-88 which pertains to "Parking - Restricted Time Limit" be amended to provide for the following:

d) <u>THAT</u> Schedule '8' of Parking Bylaw 144-88 which pertains to "Stopping Prohibited During Certain Times" be amended to provide for the following:

Grey Street	South	From a point 113m east of the centre line of Stanley Street easterly for a distance of 12m.	Anytime Every Day

e) <u>THAT</u> Schedule '7' of Parking Bylaw 144-88 which pertains to "Parking Prohibited At Anytime" be amended to provide for the following:

Name of Street	Side of Street	Location Where Parking is Prohibited
Grey Street	North	From Stanley Street to a point 82 metres east of the centre line of Stanley Street
Grey Street	South	From Stanley Street to a point 51 metres east of the centre line of Stanley Street
Grey Street	South	From Fourth Avenue to a point 40 metres west of the centre line of Fourth Avenue

4. THAT this bylaw shall become effective upon the date of its passing, save and except that any provisions of this bylaw affecting traffic on highways designated as connecting links, pursuant to Subsection 195(3) of The Highway Traffic Act, as amended, and Subsection 21(1) of The Public Transportation and Highway Improvement Act, as amended, shall not become operative until approved by the Ontario Ministry of Transportation.
