Adult Entertainer

An Adult Entertainer means a person who performs a live performance of an adult nature within an Adult Entertainment Parlour. A photo identification card is issued to each Entertainer licensed under this section and shall be produced upon request by any Provincial Offences Officer. The licensee is required to furnish 2 pieces of identification along with the required application.

On November 18, 2013, City Council passed a revised Business Licensing bylaw. As a result of this bylaw, the annual expiration date has been changed from December 31st to March 31st.

A few key highlights of the changes in Business Licensing bylaws and the schedule which your licence is issued under are as follows:

- The establishment of a late fee for failing to renew your Business licence prior to the expiration effective April 1st annually
- Creation of standard application requirements including the addition of the following to the Adult Entertainment Parlour licence category:
 - the name of the applicant, along with two forms of the applicant's current identification with at least one form being photo identification;
 - if a corporation, a copy of the constating documents of the corporation and a copy of the master business licence of the corporation;
 - original documents from the issuing agency outlining the results of investigations related to the applicant for a Police Clearance Certificate with vulnerable sector screening, dated no less than thirty days prior to the date of application for a licence or renewal; and,
- A current list containing the first and last name along with date of birth for every person that will be acting in the capacity of an operator at the adult live entertainment parlour
