For the past 25 years, Brantford Police Services has been responsible for administering the system of licensing the taxi industry in the City of Brantford. Effective January 1, 2018, this function will be transferred to the City Clerk's Department and incorporated into the City's Business Licensing Program

On November 28, 2017, City Council passed the Taxicab Licensing bylaw. As a result of this bylaw, Taxicab Brokers, Drivers and, Operators will now be licensed through the City of Brantford.

Taxicab Driver

A "Taxicab Driver" shall mean a driver of a taxicab. "Taxicab Driver" may also be referred to as "Driver".
