## **IMPORTANT INFORMATION**

**PROOF OF ALTERING:** Section 206.6.4.1 of the City of Brantford Municipal Code states “all existing dogs in the City’s Dog Licensing database identified as altered will be issued an annual licence upon payment of the applicable fee. After January 1, 2008, all newly acquired dogs or existing dogs altered after January 1, 2008, must provide the Licence Agent with a certificate from a licensed Ontario veterinarian attesting to the fact that the dog has been altered.

**PUPPY RATE:** A new dog 6 months of age or under will be charged the altered rate in the initial licensing year. To receive the altered rate thereafter, compliance with Section 206.6.4.1 Licence fee – altered dog, is required.(Proof of altering is required from a licensed veterinarian.)

**MAXIMUM NUMBER OF DOGS PERMITTED:**

Section 206.2.1 of the City of Brantford Municipal Code states “no more than 3 domestic dogs of an age in excess of six months shall be kept, harboured, maintained or possessed at any location within the City of Brantford”.

**ADDITIONAL INFORMATION:** All licence fees collected are used to help offset the costs of the Animal Services Program. This includes items such as:

- Animal control and Bylaw enforcement
- Emergency Services – injured animals
- Removal of dead carcass – small animals only on Municipal Property within 12 hours of notification
