Why we're here

- Issues of escalating poverty, homelessness, substance use, vandalism, social misbehaviours and crime are on the rise in the city's downtown, across the province, country and other parts of North America.
- These issues are not new nor unique to Brantford, though have been clearly and significantly exacerbated by economic hardships due to the ongoing pandemic.
- Businesses, institutions, residents and Brantford City Council have expressed the need for immediate action to mitigate these issues in the city's downtown.

Task Force Mandate




DBITF Task Force Mandate

- The Council appointed Task Force is a collaborative community forum in which various entities and organizations across all business sectors and community organizations are sharing information and resources to assist in developing an action plan to improve the health and vitality of the downtown.
- Three sub Working Groups of the Task Force are currently working independently to develop short and long-term steps to address challenges in the city's downtown.
- The 3 focus areas of the Working Groups and ultimate action plan are Community Services, Economic and Cultural Vitality and Safety and Security.

Community Services Working Group

Community Services Working Group

- Made up of a collaborative of community agencies and organizations and City staff who focus on the delivery of community services to vulnerable populations.
- This sub working group's objective is to work collectively to provide additional supports to vulnerable and marginalized populations including but not limited to, individuals experiencing homelessness, those with substance use disorders, and those suffering from mental health and addictions.
- Working group will hold specific consultations involving individuals with lived experience
- This information together with the information from other community consultations, review of available services, and needs analysis will be used to develop a prioritized action plan that will be presented to the Task Force



Economic and Cultural Vitality Working Group

- Made up of a collaboration of businesses, the downtown neighbourhood association and academic institutions.
- This sub working group's objective is to enhance the vitality of the downtown by expanding business, tourism, arts, culture, music, entertainment and community events to attract more people downtown and ultimately improve the vibrancy of the city's core.
- The group is currently completing a comprehensive community inventory of Downtown initiatives and resources related to Economic Development, Tourism and Community Programming.
- On October 18th, the group also completed a virtual stakeholder engagement workshop where short, medium and long term action items were identified and prioritized that will be integrated into the forthcoming Action Plan.

Safety and Security Working Group

Safety and Security Working Group

- Working collaboratively with safety and security partners to implement actions to address current safety concerns of businesses, residents and visitors.
- The group's objective is to make recommendations to the Task Force on initiatives that enhance current safety and security measures to improve individuals' perceptions of and experiences in the downtown.
- The group is currently completing a comprehensive community inventory
 of downtown safety and security resources to enhance and strengthen
 coordination across agencies and organizations; looking into potential
 avenues to advocate for court process improvements/allocation of
 additional judicial resources in this region; and also reviewing best practices
 in other, similarly situated BIAs.
