- 2. **THIS COURT FURTHER ORDERS** that, until another court order is made on December 29, 2021 or otherwise, the defendants and any person who has notice of this order are restrained from:
 - (a) trespassing, continuing to trespass, or further trespassing on the property located at 282 Stanley Street in Brantford, Ontario, formerly the Arrowdale municipal golf course (the "**Property**"); and
 - (b) interfering with, disrupting, obstructing, hindering, impeding, or otherwise interfering with access, ingress, or egress to the Property by City Staff, or its contractors, consultants, or agents or with any of their activities on the Property.
- 3. **THIS COURT FURTHER ORDERS** that the Sheriff of the City of Brantford shall enforce forthwith the terms of this order and prevent or stop breaches of this order and shall

be authorized to seek for these purposes the assistance of the Brantford Police Services (the "Police") to accompany and assist the Sheriff including to arrest and remove any person who the Police officers have reasonable and probable grounds to believe is contravening, or has contravened, the provisions of this order except that each Police officer retains his or her discretion on the means and timing of any arrests and removal.

- 4. **THIS COURT FURTHER ORDERS** that service can be effected on the defendants as follows:
 - (a) On Dan Oakes by email at unless and until he retains legal counsel;
 - (b) On Kailee Poisson by email at ____unless and until she retains legal counsel;
 - (c) On Trevor Bomberry, Kurt Hadowas Gibson aka Gizzo and Alexander Dawson by:
 - (i) Informing the Police's Indigenous Liaison Officer and the Police's Indigenous Liaison Officer informing Colin Martin; and/or
 - (ii) Posting/leaving documents outside the access gates to the Property along with an announcement by megaphone if safe to do so; and/or
 - (iii) Direct message to Trevor Bomberry's and Alexander Dawson's Facebook profiles.
