RE: Mayor's 2024 Budget Adjustments

Summary

This budget submission is in compliance with the Strong Mayor Legislation which requires that the Mayor submit a proposed budget for council's consideration on or before February 1st, 2024.

Last summer I directed City staff to follow a hybrid approach to the preparation of the Mayor's budget by blending the past budget procedure with the requirements of the Strong Mayor legislation.

That blended process commenced on January 10th, 2024 with staff presenting to Council's Estimates Committee a proposed budget for committee's review in determining what changes it recommend be made to the staff budget for inclusion in the Mayor's budget.

The proposed staff budget presented on January 10th called for a 4.99% property tax increase to fund those services provided by the City ("Controllable City Costs"). The impact of the budgets submitted by agencies outside of the City, such as Police Services, Health Unit, Library, John Noble Home ("Uncontrollable Costs") elevated the proposed total property tax increase from 4.99% to 6.48%.

The Estimates Committee's process for determining recommendations for the Mayor's budget was finalized at the January 30th council meeting, when Council considered a list of suggested changes to the staff budget. Those suggested changes would have reduced the proposed property tax increase to fund Controllable City Costs from 4.99% to 4.87%, reduced the Uncontrollable Cost of outside agency budgets from 9.48% to 7.74% and lowered the total proposed property tax increase from 6.48% to 5.82%.



Although the list of suggested changes did not receive final Council approval, I have considered the staff budget and the Estimates Committee's suggested changes as the starting point for the Mayor's Budget Adjustments. The Mayor's Budget Adjustments further reduces the proposed property tax increase to fund Controllable City Costs from 4.87% to 4.24% and reduces the total proposed property tax increase from 5.82% to 5.41%. The Estimates Committee's recommendations, combined with the Mayor's Budget Adjustments, reduces the annual tax increase for the average residential tax payer from \$227.51 to \$189.83.

In accordance with previous Council direction, the staff prepared budget also included the first ever multi-year budget for the City. The development of a multi-year budget for 2024-2027 takes a longer term approach to budgeting, and gives more consideration to the requirements needed to deliver on Council's priorities. It is expected to provide a number of benefits, including greater certainty and accountability for future budget increases. My budget includes a multi-year projection, and demonstrates the amendments proposed are expected to keep property tax increases at or below 3.8% in each of the next three years.

I have attached a list of the Estimates Committee's suggested changes and Mayoral Budget Adjustments. I have also included an explanation for each of the ten Mayoral Budget Adjustments.

This however is not the end of the budget process. Under the Strong Mayor's legislation my council colleagues can make further Budget Adjustments. A special council meeting for that purpose has been scheduled to take place on February 20th.

To ensure the 2024 budget process is as democratic and transparent as possible, I intend at the February 20th meeting to make a presentation regarding the Mayor's Budget Adjustments and thereafter answer any questions that Council members may have. I also pledge not to veto any budget adjustments approved at that meeting. I do this as I have the utmost respect and confidence in each council member and am confident that they will, in their budget decision making, act reasonably and in the best interest of our community.

Mayoral Budget Adjustments

Adding \$100,000 for Indigenous Advisory Services

Estimates Committee suggested that the Indigenous Relations position should be removed as a cost saving measure. This runs counter to a stated Council priority of focusing on productive and collaborative partnerships, including that with the Indigenous Nations in the Grand River watershed. It is essential, if there is to be a focus on enhancing those relationships, that we from time to time receive advice and counsel from inidividuals or organizations that have expertise in Indigenous Affairs. In my view the most effective and cost efficient method for doing that is by retaining an outside consultant(s) rather than by hiring a full time staff person. I have therefore included in this budget the sum of \$100,000 to be used for the purpose of obtaining Indigenous consulting services and advice.

Reduce Winter Control by \$627,000

The staff budget allocates \$4,627,793 for Winter Control, more commonly known as the City's snow removal program. In 2022 a reserve was set up for this account to hold any annual operating surpluses. The reserve is to protect the City from cost overuns that can occur during a severe winter season. After three years the balance in the reserve is estimated to be approximately \$3,000,000.

The cost of snow removal over the last 5 years has averaged \$3.5 million dollars annually. In 2023 it is estimated to be \$3.2 million and in 2022 \$3,442,247. It is reasonable to expect it will be even lower this year with the mild winter we have been experiencing. Reducing this budget item to \$4,000,000 should be more than enough to cover expected snow removal costs this year and will almost certainly give rise to a surplus that will be added to the reserve at year end. I suggest this item be revisited in future years once the balance in the reserve exceeds \$4,000,000.

• Adding \$6,600 for Bulldog game day parking

The parking garage is not being used by people attending Bulldog games. There are several reasons for that one of the most significant being that it costs \$2.25/hour to park in the Parkade during the week, while there is no charge for parking in the Civic Center and Earl Haig parking lots. Many of the fans are also parking in the Freshco parking lot, to the consternation of some Freshco mall patrons. To encourage use of the Parkade by Bulldog fans this budget provision includes a direction to staff to provide free parking, in the parking garage, for weekday games. The \$6,600 is staff's estimate of the annual parking revenue that will be foregone with this change in the operation of the Parkade and the parking fee structure.



- Remove Proposed Aquatic Arena Operator and Solution Hub
 Although these are reasonable budget requests by staff, they are not in my view essential or in support of Council's stated priorities. They should be reconsidered in some future budget year that has fewer budgetary pressures then what we are currently experiencing.
- Remove shift from Capital to Operating for certain Public Works positions
 The Public Works budget submission proposed shifting from Capital to Operating 5% to 10% of
 the salary and benefits for 4 positions, such as Manager of Design and Construction. I remain
 unconvinced that policy shift is necessary or advisable and have reversed that shift for a total
 budget reduction of \$43,814.
- Remove cost of 150th Bell Homestead from Operating Budget
 Staff assure me that the \$25,000 cost for this much anticipated event will likely be paid by government grant, and in the event grant monies are not awarded, then through reserves.
- Reduce contracted Stump Grinding and Cyclical Pruning by 25%
 Estimates Committee suggested this service enhanced be reduced by 25%. Given that this is an extremely difficult budget year I have further reduced this service by an additional 25% for 2024, and have restored to the level suggested by the Estimes Committee in 2025.
- Alternate Method for financing addition to Physician Recruitment
 Estimates Committee suggested that \$35,000 be added as a one-time increase to the Physician
 Recruitment budget in 2024. I agree with that decision but instead of that amount be adding to
 the operating budget, have directed that it be paid from Casino reserves.
