

The City of Brantford is creating a new Official Plan to guide growth and development to the year 2041. The new Official Plan will account for the Boundary Expansion Lands that were transferred from Brant County to the City in 2017, and conform to the Province

## of Ontario's 2019 Growth Plan for the Greater Golden Horseshoe. What will Brantford look like in the future?

Earlier this year, City Council endorsed a future Settlement Area boundary and targets for intensification and density to shape where Brantford will grow. The Official Plan Review program is now expanding its recent focus on the municipal Boundary Expansion Lands to also address the land use plan and urban design guidelines for the entire City of Brantford.
