The City of Brantford will be hosting a Public Information Centre on a City Initiated Zoning By-law Amendment. Please see details on the proposed draft amendment below:

Application PZ-18-18 involves City Initiated Amendments to Zoning By-law No. 160-90 to update various zoning regulations. These modifications are housekeeping in nature and are collected by City Staff from the ongoing administration of By-law No. 160-90 and related planning applications. The matters to be considered as part of this amendment are technical in nature and will ensure that the current Zoning provisions are consistent with Provincial policy and to address the changing nature of the community and development within the City. The following matters have been identified and are proposed to be addressed:

- Housekeeping Items to correct typographical and mapping errors, update terms to reflect current Provincial policy and reorganize definitions for ease of reference.
- Spatial Separation between townhouse blocks to create a provision requiring a minimum spatial separation distance of 3 m between street townhouse units and block townhouse units for Fire Department access purposes.
- Model Homes to create a general provision that regulates the use of model homes for future plans of subdivision.
- Parking Spaces to review and modify parking standards as they relate to the required amount, size and location of off-street parking spaces (Section 6.18). The current standard parking space size in Brantford is 2.75 m x 6 m, and the average standard parking space size of comparable municipalities is below this.
- Accessory Retail Sales to review the physical separation requirement for internal accessory retail sales. Currently, Section 6.3.6.3 of the Zoning By-law requires that the gross floor area used for accessory retail sales shall be separated from the main manufacturing or warehousing use by a permanent, solid, floor-to-ceiling and wall-towall partition and closed doors.
- Interpretation to clarify that the plural provision in the interpretation section does not apply to placing multiple buildings on a lot where only one building is permitted (Section 3.2.2.2).

NEW CONSTRUCTION PROPERTIES

For newly constructed / renovated homes or buildings, it can take up to three years for the assessment to be given to the City, but taxes are payable from the date of fit-foroccupancy or possession.
