## NOTICE OF STATUTORY PUBLIC MEETING **REGARDING 2019 DEVELOPMENT CHARGES BACKGROUND STUDY**

Take notice that on Tuesday, March 5, 2019, the Council of the City of Brantford will hold a public meeting pursuant to The Development Charges Act, 1997, regarding proposed development charge rates and policies that will be applied throughout the City. It is proposed that enactment of a development charges by-law by Council would occur on a date subsequent to the public meeting.

Development charges are levied against new development, and are a primary source of funding for development-related capital expenditures. The 2019 Development Charges Background Study relates to the provision of all eligible DC Services (i.e., Fire, Police, Library, Parks and Recreation, Public Transit, Housing, Municipal Parking, Land Ambulance, Public Works: Buildings and Fleet, General Government, Water, Wastewater, Stormwater and Roads and related infrastructure).

Council is required under The Development Charges Act, 1997, to hold at least one public meeting to allow the public the opportunity to review and provide comments on the 2019 Development Charges Background Study, related staff reports and the proposed development charges by-law.



# Protect Water Pipes from Freezing

Extreme cold temperatures can cause water pipes inside the house to freeze. Plumbing within a basement or unheated areas of a building can freeze if not properly insulated from the extreme cold. This can happen due to drafts or broken or open windows. Water can also freeze where plumbing runs through uninsulated areas within drywall or crawl spaces.

#### **Tips on Prevention:**

- Maintain a minimum room temperature of 12 degrees Celsius (55 degrees Fahrenheit) where the water service comes into your home- even when you are on vacation.
- Seal air leaks in your home and garage, including repair of cracked or broken windows.
- Vulnerable sections of plumbing in uninsulated areas may need to be warmed with a heat lamp or space heater.
- Apply a sleeve of foam insulation to exposed plumbing located on exterior walls or in cold rooms of your home such as crawl spaces, cold cellars, basements, attics, storage rooms, and garages.
