Amendments to the City of Brantford Zoning By-law 160-90 and County of Brant Zoning By-law 61-16 respecting a "Temporary Use By-law to Permit the Use of Recreational Vehicles"

PURPOSE AND EFFECT OF PROPOSED APPLICATION

The purpose and effect of this Temporary Use By-law is to establish temporary zoning provisions to permit the use of recreational vehicles such as motor homes and travel trailers for temporary occupancy in order to provide an alternative form of accommodation during the COVID-19 pandemic for front-line workers, individuals that may have tested positive for COVID-19 or for individuals that need a location to quarantine away from others in the household. As directed by Council, a Temporary Use By-law under Section 39 of the Planning Act has been prepared for a maximum of three (3) years, and could potentially be extended beyond the Declaration of Emergency, but shall not be rescinded before the Declaration of Emergency expires or has been terminated.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the City of Brantford before the By-law is passed, the person or public body is not entitled to appeal the decision of the City of Brantford Council to the Local Planning Appeal Tribunal. If a person or public body does not make oral submissions at a public meeting, or make written submissions to the City of Brantford before the By-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.
